

*Students who do not meet Palomar College's Financial Aid, Veterans & Scholarship Services (FAVSS) Satisfactory Academic Progress (SAP) standards are not eligible for Cal Grants or any federal financial aid including Pell Grant, Federal Supplemental Educational Opportunity Grant (FSEOG), Work Study (FWS) and direct loans at the College. Students may request reinstatement of their eligibility for federal aid based on an extenuating circumstance by submitting a SAP Appeal.*

### **Deadlines**

Fall 2020- December 3, 2020

Spring 2021- May 7, 2021

Summer 2021- June 25, 2021

***Appeal eligibility will not be retroactive to prior terms***

### **Extenuating Circumstances include:**

- Severe illness or injury,
- Death of immediate family member or
- Other unforeseen extenuating circumstance
- Recent disability or job layoff that requires retraining or further education to a different career;

**Appeals should be detailed and must include documentation that supports your extenuating circumstance(s). Keep a copy of all documents you submit for your records.**

We encourage you to print an unofficial copy of your academic transcript to help you address the specific semester(s) that affected your overall academic performance.

*For example, if you received multiple Ws, FWs or Incompletes in a particular semester you can determine if an extenuating circumstance occurred in that semester and use that as a basis for your appeal.*

You may also obtain a statement from a college instructor or academic counselor (*available by appointment only*) if he/she can confirm or support your request for reinstatement based on one or more of the extenuating circumstances listed above.

### *Completing the SAP appeal form*

Select the extenuating circumstance and disqualification reason that pertains to you. Refer to your disqualification notification for details. **Reminder:** *Communications are sent to your Palomar College student email address.*

### **Disqualification Reason**

- **Section 1:** Complete this section if you did not meet the minimum 2.00 cumulative GPA or 67% pace (cumulative completed vs. attempted units) standards.
- **Section 2:** Complete this section if we have determined that you have attempted 100% or more of your declared academic major **and** that you will *not* finish your program by the 150% unit limit based on your current Educational Plan.

**Note:** FAVSS recognizes the academic major reported by the Admissions Office only. Any "External major" listed on the Education Plan is not recognized as your official academic major with the college.
